d. Airfare Reimbursement: Yushan Fellows may cover airfare expenses under the research support budget (operational expenses).

e. Health Check Services: Preferential health check services are offered at the university-affiliated hospital to faculty and staff.

This case will be handled in accordance with the provisions of the "Operation Directions Governing Verification, Allocation and Account Finalization of Ministry of Education Subsidies (Donations) and Commissioned Funding". The items of applying for to fund academic collaboration and administrative support expense include second-generation National Health Insurance (NHI) program supplementary premium of additional to statutory salary of Yushan (Young) Fellows, assistant personnel expenses, and general expenses of teaching, research and international collaboration.
